RULES FOR THE USE OF THE POOL AND ANTI SARS-CoV-2 STANDARDS

Before entering the swimming pool, please take a look of these rules.

- 1. The use of the private swimming pool is allowed only to guests of the Masseria Fragnale structure and its owners.
- 2. External guests are not allowed, unless expressly authorized by the management of the structure.
- 3. Access is allowed only during the hours from 09:00 to 19:00.
- 4. Please note that there is no lifeguard assistant and therefore it is not supervised.
- 5. The use of a swimming cap is mandatory.
- 6. It is mandatory to take a shower before entering the water, in any case it is forbidden to enter the tub with tanning and protective creams and hair oils, without having taken a shower first.
- 7. It is forbidden to swim in bad weather conditions.
- 8. It is forbidden to smoke and consume food or drinks in the bathing area.
- 9. For all those who cannot swim, armbands or life jackets are mandatory.
- 10. It is forbidden to use the towels supplied within the room.
- 11. It is forbidden to throw papers, cigarette butts or anything else in the water or in the garden.
- 12. It is forbidden to bring in containers and / or objects made of glass, hard plastic or metal and other objects not strictly related to bathing.
- 13. It is forbidden to run on the pool side surface, push other into the water and diving (Attention the height of the pool does not allow this, so it is very dangerous).

- 14. It is forbidden to play dangerous games or any games that may disturb other guests.
- 15. It is forbidden to shout or raise one's voice, everyone is required to behave in such a way as not to cause discomfort and inconvenience to other guests.
- 16. Children under the age of 18 must be accompanied by an adult who assumes responsibility and is able to intervene in case of need.
- 17. It is forbidden for younger children to stay near the pool without parents or an accompanying adult.
- 18. Very young children must wear a nappy or a swim nappy.
- 19. It is forbidden to use the beds without covering them with a towel
- 20. All pool equipment must be used with care and attention. Any damage caused must be compensated.
- 21. In the case of solitary presence inside the pool, it is advisable not to immerse yourself in the water.
- 22. It is advisable to allow an interval of at least 3 hours between the meals and bathing.
- 23. It is forbidden to bring animals into the pool and surrounding area.
- 24. It is forbidden to bring inflatables for children and mattresses into the pool.
- 25. It is forbidden to introduce and consume any type of food and drinks contained in glass bottles or glasses in the pool and adjacent spaces.

Those who access the pool accept these regulations and the conditions described.

Which is visible to guests in each room / apartment, posted prominently in the bathing area and on our website.

- The pool measures 4 MT x 10 MT and has a depth of 1.50 MT.
- Guests will use the swimming pool in strict compliance with this regulation.

- Guests use the pool at their own risk, exempting other guests, the management, as well as the property from any liability, both criminal and civil.
- The Management declines all civil and criminal liability for objects or valuables left in the pool and for any accidents, injuries, or other caused by guests to themselves and to third parties, especially if in violation of this regulation.
- To ensure efficient maintenance of the state and hygiene of the swimming pool, common sense, education and cooperation of all are used.

ANTI SARS-CoV-2 REGULATION

- The facility is equipped with a dispenser with hydroalcoholic solutions for hand hygiene. It is therefore recommended to use them frequently.
- It is recommended to use the bathrooms inside the structure for proper personal hygiene and frequent hand washing.
- The crowding density in the water must not exceed 7/8 contemporary presences.
- The distance between the beds, between people not belonging to the same family, must be at least 1.5 meters.
- It is forbidden to spit, blow your nose and urinate in the water.
- The mixed use of sunbeds, deck chairs and towels is prohibited.
- Parents / carers are recommended to take care to supervise children in order to respect
 the distance and hygiene and behavioural rules, compatibly with their degree of
 autonomy and their age.
- The structure adopts all the hygienic and sanitizing rules of the waters and common structures.
- The beds are sanitized at the end of the day and at each change of user as well.
